

TERMS AND CONDITIONS

1. Booking & Payment

- A 50% advance payment is required to confirm and secure your booking.
- The remaining balance must be paid before the end of the rental session.
- All advance payments are non-refundable.
- All prices quoted are exclusive of GST. If a GST invoice is required, an additional 18% GST will be applicable.

2. Cancellation & Rescheduling

- A booking may be rescheduled only once, subject to studio availability.
- Bookings cancelled less than 24 hours before the scheduled session will result in forfeiture of the advance payment.

3. Rental Time

- The rental period begins at the scheduled booking time or when the client first enters the studio, whichever occurs earlier.
- The booking ends only after the client and their team have completely vacated the premises.
- Any delay in arrival by the client will be considered part of the booked rental time.
- No additional time or compensation will be provided for late arrivals.

4. Overtime

- Setup, shooting, and pack-up must be completed within the booked time.

- Overtime charges will apply for any time exceeding the agreed rental duration.

5. Studio Usage

- Smoking and consumption of food are strictly prohibited inside the studio.
- Clients must keep the studio clean and tidy throughout the session.
- Additional cleaning charges may apply if the premises are left excessively untidy.
- High-power or heavy electrical equipment must be approved by the studio before use.
- Studio personnel may enter the premises during the booking period for operational, maintenance, or safety purposes.

6. Guests & Crew

- The expected number of people attending the shoot must be informed in advance.
- Entry of additional crew members or guests is subject to prior approval and may incur additional charges.
- Bookings are non-transferable and may not be assigned or sublet without prior written approval from the studio.

7. Equipment & Add-ons

- Cameras, lenses, tripods, props, lighting equipment, and other studio accessories are available for rent at an additional cost, subject to availability.
- If a studio assistant is required during the session, additional charges will apply.

8. Client Responsibilities

- Submission of a valid government-issued ID proof is mandatory before the session.
- Clients are responsible for any loss or damage caused to the studio premises, furniture, equipment, or accessories during the booking period.
- Clients are responsible for ensuring that all members of their team comply with the studio's rules and regulations.

9. Liability

- The studio is not responsible for the loss, theft, or damage of any personal belongings brought onto the premises.
- The studio is not responsible for any loss or damage to vehicles or belongings left inside parked vehicles.
- The studio reserves the right to refuse bookings or terminate an ongoing session without refund if these Terms & Conditions are violated.

10. Force Majeure

- In the event of circumstances beyond the studio's reasonable control, including but not limited to natural disasters, government restrictions, power failures, technical failures, or emergencies, the studio reserves the right to reschedule the booking without liability or compensation.

11. General Terms

- These Terms & Conditions apply to all studio bookings unless otherwise agreed to in writing.
